All memberships are considered yearly memberships and payable in full as of the first billing each membership year. If a member prefers, monthly installments can be paid in equal monthly installments as set forth above. If a membership is cancelled during the membership year, the entire balance remaining for the year, including unpaid initiation fee, shall be payable in full at that time. The current initiation price is listed above and can be paid in full upon application or in monthly installments for a maximum of two (2) years. Junior memberships will be required to pay the initiation fee at age 35 at the price then existing and the member will be transferred to a Young Professional classification. Sales tax is applied to all charges listed.
